

**Village of Halkirk**  
**Campground and Recreation Fees Bylaw - Bylaw # 2024 – 001**

Being A Bylaw of the Village of Halkirk, in the Province of Alberta to Establish Fees for Halkirk Recreation Grounds and Halkirk Camping Facilities.

Whereas Council of the Village of Halkirk in the Province of Alberta under the Authority of the Municipal Government Act Chapter M-26 may pass bylaws for the purpose of operating a municipal campground within the Village of Halkirk.

AND WHEREAS, Council of the Village of Halkirk deems it necessary to establish fees and rates for the Halkirk Recreation Grounds and Campgrounds;

NOW THEREFORE, the Municipal Council of the Village of Halkirk duly assembled enacts as follows:

1. This Bylaw may be cited as the “Campground and Recreation Grounds Fees” Bylaw.
2. In this Bylaw:
  - a. “Berry Street Campsite” means the campsite located at 110 Berry Street, serviced with power, water and sewer.
  - b. “Recreation Grounds” means the Halkirk Community Recreation Grounds Facilities located at 302 Main Street.
  - c. “Rodeo Grounds Campsite” means any area within the Halkirk Community Recreation Grounds that may be used for unserviced overnight camping.
  - d. “Non-Designated Camping” means unserviced overnight camping, that has been pre-approved by Village Administration, on any public land owned by the Village of Halkirk which is not specifically designated a campsite.
  - e. “Serviced” means the campsite has power, water, and sewer hookups for Recreational Vehicles.
  - f. “Unserviced” means that there is no power, water or sewer hookups.
  - g. “Weekly Rate” means the amount charged for one week (seven consecutive days) of camping, where the day of arrival counts as Day One.
3. Rates and Fees:
  - a. Berry Street Campsite Rate shall be \$40.00 per day per camping unit; or Weekly Rate of \$225.00 per camping unit.
  - b. Recreation Grounds Campsite Rate shall be \$20.00 per day per unit; Non-Designated Camping Rate shall be \$20.00 per day per camping unit, with a maximum stay of two consecutive days.
  - c. Recreation Grounds Rental Rate shall be \$100.00 per day, which includes the Concession/Washroom building, and the Pole Shed Building.
  - d. Rental of the Rodeo Arena shall \$100 per day.
  - e. Rental of the Halkirk Recreation Grounds Facilities does not include free camping.
4. Registration and Payment shall be completed as soon as the campsite is occupied. Payment is accepted by cash, cheque, or Electronic Funds Transfer.

5. Severability: Every provision of this bylaw is independent of all other provisions and it is the intention of Council that if any provision of this bylaw is declared invalid by a court, all other provisions of this bylaw shall remain valid and enforceable.
6. That Bylaw # 004-2022 Fees and Rates Bylaw Campgrounds be repealed.
7. That this Bylaw shall become effective upon receiving third and final reading.


Read and Passed a First Time March 14, 2024,


Read and Passed a Second Time March 24, 2024
